Driving Directions to the Church

Traveling East from Oakland or Orinda on Highway 24...

Exit at Acalanes Road, which is before Lafayette

At the bottom of the off-ramp, turn right at the traffic signal

Proceed two blocks to the stop sign and turn right onto Hidden Valley Road Immediately turn left onto Knox Drive Proceed up the hill, the church is on the right with the parking lot entrance as you come around the curve.

Traveling West from Walnut Creek or Lafayette on Highway 24...

Exit at Acalanes Road, which is before Orinda

Circle under the freeway and go through the intersection with the traffic signal Proceed two blocks to the stop sign and turn right onto Hidden Valley Road Immediately turn left onto Knox Drive Proceed up the hill, the church is on the right with the parking lot entrance as you come around the curve.

Parking

Free parking is available in the church's parking lot. If the lot fills, street parking is also available but may involve a walk up the hill.

Public Transportation

Public Transit will not easily get you to the church. The BART stop in Lafayette is about 2 1/2 miles from the church. There does not seem to be a local bus service. Walking would take 50 minutes to an hour. You could try a ride service to get there from BART – and then on the way back, ask another presbyter for a ride!
